## The University of Papua New Guinea (UPNG)

The University of Papua New Guinea is prominently located in the heart of Port Moresby, the nation's capital, and is spread over two campuses, viz Waigani Campus and Taurama Campus. While Waigani Campus, with a land size of 405 hectare, houses administrative headquarters of the University and four Schools, such as, School of Business Administration, School of Humanities and Social Sciences, School of Law and School Natural and Physical Sciences, Taurama Campus houses School of Medicine and Health Sciences.

In addition, there are University Open Campuses and University Centres in a number of provinces, jointly run by the UPNG Open College and respective Provincial Governments.

UPNG also has a 19-hectare multi-disciplinary marine research station on the historical site, Motupore Island, outside of Port Moresby. Motupore Island is located adjacent to the popular Loloata Island Resort, and is serviced by the Tahira Marine Centre, located onshore.

Various schools of the University are made up of Divisions or Strands or disciplines with particular emphasis on knowledge relevant to, and on the needs of Papua New Guinea.

**MISSION STATEMENT:** To be the Premier University, making available quality education, research and service to Papua New Guinea and the Pacific.

**OBJECTIVES**: The objectives of the University, as expressed in the University Act, are:

- 1. to be dedicated to the pursuit, advancement and dissemination of knowledge, understanding and wisdom.
- 2. pursue the objectives specified in sub-section (1), the University shall be mindful of the manpower and other needs of Papua New Guinea and shall endeavour, by the example of its corporate life, academic achievements and professional excellence, to promote national well-being and progress.

#### **UPNG Facilities**

In order to provide adequate support to all the students, a vast range of facilities and services are available:

**Libraries**: There are two main libraries that serve the needs of the students, lecturers, researchers and stakeholders of the University. The Michael Somare Library, located on the Waigani campus, has a vast collections of materials relevant for the four schools – School of Business Administration, School of Humanities and Social Sciences, School of Law, and School of Natural and Physical Sciences. It has a collection of 300,000 books on various fields and over 2,000 online journals and print edition of journals. The Law section's collections of 25,000 volumes are noteworthy, with particular strength in Pacific and Common Law jurisdictions.

The Michael Somare Library has excellent coverage for all New Guinea, Pacific and Third World topics; and there is a separate New Guinea Collection in which one copy of everything published about Papua New Guinea and Irian Jaya, are placed. It has a

unique collection of early photographs, which are heavily used for publication purposes.

Other facilities includes a newspaper reading area, a paperback browsing collection, new-books displays, e-lbirary / e-books section, photocopying service, micro-filming, access to microfilm readers, tape-slide viewers, and loop playing machines and videos. Frequent exhibitions are mounted in the Library.

**Bookshop:** A range of recommended textbooks written by local or international authors are always available in the bookshop. The University Bookshop is located in the Gunther Building at the Waigani campus. It exists primarily to supply textbooks and stationery to students and staff of the University. It also serves the public as a general bookshop and supplier.

**Health Clinic:** A medical clinic is situated on the Waigani Campus. It provides basic health services: consultation, immunisations and treatment for common diseases to students, staff and their families, as well as to members of the public from surrounding suburbs.

# School of Business Administration (SBA)

The School of Business Administration (SBA) was established in 2002 under the academic reforms at the UPNG. The School is responsible for training students with appropriate skills and knowledge relevant to business, government, and financial institutions.

The SBA has positioned itself as a leading School of Business and Management in Papua New Guinea, and one of the emerging Schools of Business and Management in the Asia-Pacific region. The School was the recipient of the prestigious Commonwealth of Learning Award for its Management programme in 2004. The School has been voted as one of the top 1,000 business schools in the world and the best business school in Papua New Guinea with significant regional impact (two palms grade) through Eduniversal International Scientific Committee (Visit <a href="www.eduniversal.net">www.eduniversal.net</a>). The School currently offers Bachelor programs in Accounting, Banking & Finance, Business Management, Economics, Human Resources Management, Public Policy Management, Strategic Management, Tourism and Hospitality Management, and Masters Programs in Business and Management viz., Executive Master of Business Administration, Master of Human Resource Management, Post-graduate Diploma in Strategic Management and Master of Strategic Management (MSM). In addition the School proposes to offer Doctor of Business Administration (DBA) program.

Our programs are continually being assessed externally through arrangements with Universities in Canada, Europe, India, Singapore, Fiji, New Zealand, and Australia as well as by the industry and professional bodies in Papua New Guinea, for its industry relevance and focus. In addition, the staff undergoes an evaluation every semester as part of the School's quality assurance process.

On a regular basis, the School invites qualified and experienced personnel from professional organisations, civil services and the business community to deliver lectures, seminars, and workshops to our students and some of these people hold part-time teaching status in the School.

#### **Academic Staff**

The School, currently, has staff strength of around thirty five and they are spread across seven divisions, namely Accounting and Banking and Finance, Business Management, Economics, Human Resource Management, Public Policy Management, Strategic Management and Tourism and Hospitality Management.

The School is manned by some of the most highly qualified academics with academic and professional qualifications from prestigious institutions in the U.S., Europe, Australia, and Asia.

## Master of Human Resource Management (MHRM)

**Note:** This programme is designed, developed and managed by The University of Papua New Guinea and being offered at the premises of Papua New Guinea Human Resource Institute (PNGHRI).

Master of Human Resource Management program designed for working executives, who are currently holding managerial or supervisory positions. This program provides an academic platform to update and upgrade their managerial competency level in order to perform human resource management tasks more effectively and innovatively.

### **Admission Requirements**

Admission to UPNG MHRM Program is granted only to those who are able to benefit fully from this intensive program. Applicants are expected to have reasonable work experience in a position involving considerable authority and decision-making.

Applicants should:

- a) have a good first degree from an approved University or equivalent qualifications:
- b) have a minimum of five years managerial-level work experience or five years of supervisory work experience acquired after first degree; and
- c) be fluent in English and be a computer literate.

### **Program Structure**

Master of Human Resource Management program is a course-work program, which is available on part-time basis only. Every candidate is required to complete fifteen specified courses over a period of two years. There are three terms (trimester) every year, each of which is 12 weeks long. Every candidate will be registering for two or three courses during every term.
